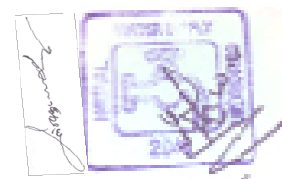

Nepal Water Supply Corporation (NWSC), Head Office, Tripureshwar Kathmandu invites sealed bids for the Construction of RCC Water Tank Reservoir capacity (250 cum) for NWSC branch office Dhangadhi, from eligible registered contractors having qualification and requirements as mentioned in the bidding document under National Competitive Bidding.

All the purchased bid document shall be sealed in an envelope and must be submitted addressing to **The Procurement Officer, Nepal Water Supply Corporation Head Office, Tripureshwar Kathmandu, before 12:00 hours of 31st day (i.e.2071/04/29)**. Envelop must bear the contract identification no, bidders name and address with contact Telephone/fax no. Alternatively, bidders may submit their Bids electronically through e-procurement section of DoR's web site <http://www.dor.gov.np>. as specified in the instruction to bidder. Documents received after this deadline shall not be accepted.
4. Bids shall be opened in the presence of bidders representative who choose to attend at **14:00 hours, on the last date of submission (i.e.2071/04/29)** at the NWSC Head Office, Tripureshwar Kathmandu. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by bid security, amounting to **NRs.200000.00** which shall be **valid for 120 days** from the date of Bid opening.
5. If a bidder wishes to submit the bid security in the form of cash, the cash should be deposited in Nepal Water Supply Corporation Current **Account no. 0201017500742 at Nabil Bank, New road, Kathmandu** and submit the original receipt of the deposited amount along with the bid.
6. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day.
7. Bidders are advised to visit site and assess the actual site conditions accessibility, availability and cost of construction materials before submitting their bid at their own responsibility.
8. A Pre-bid meeting will take place on the **20th day from first date of publication of this notice** at Nepal Water Supply Corporation, Head Office, Kathmandu **at 13:00 hours** if that day falls on a Government holiday then the meeting will be held on next working day.
9. Bidders may bid as a single contractor or in a firm of Joint venture of maximum number of two (2) contract firms. In the case of joint venture, any one partner shall have to meet the required criteria of specific work experience; the partner In-charge (lead partner) shall have minimum 40 percent of required average annual turnover and the liquid asset and other partners shall have minimum 25 percent of the same.
10. Subject uncovered under this notice shall be in accordance with Public Procurement Act 2063 and the Public Procurement Regulation 2064.
11. The unit price furnished in words shall prevail in case of any discrepancy between figures and words.
12. The employer reserves the right to accept or reject, wholly or partly any or all the bids or cancel the bidding process without assigning any reason, whatsoever.
13. In case of discrepancies or error in bidding document, tender notice or any other documents the NWSC reserves the right to amend and correct at any time.
