5. Sealed Bids must be submitted to **Nepal Water Supply Corporation, Tripureswor, Kathmandu** on or before 12:00 hours noon on **31 days from first publication date.**

Bidders may submit their bid electronically through e-procurement section shall log on to the webdite of Department of Roads (DoR) <http://www.dor.gov.np> or <http://eproc.dor.gov.np> as specified in the Instructions to Bidders. Bidders may also choose to download the necessary parts of the bidding document, prepared and submit their bids electronically as specified in the Instruction to Bidders upon paying the non-refundable fee as specified above in **Current Account No. 0201017500742 of this office opened in Nabil Bank, New Road, Kathmandu** and submit the scanned electronic copy (pdf format) of the bank receipt along with the electronic bid files.
7. Bids shall be **valid for a period of 90 days** after the deadline of bid submission. All bids must be accompanied by a bid security of amount mentioned above, **valid 30 days beyond Bid validity date.**
8. Bank Guarantee issued by any finance company in any form will not be accepted.

10. Bids received after the deadline of the submission will be rejected. Bids received by the above mentioned deadline shall be opened physically and electronically in the presence of the Bidders

representatives who choose to attend at the address above at 13:00 Hours on ***31 days from the first date of publication.***

11. If the last day for purchasing and submission falls on a government holiday then the next working day shall be considered as the last day.
