Nepal Water Supply Corporation (NWSC), Head Office, Tripureshwor, Kathmandu invites sealed bids of proposals (Technical and financial) for the construction of **RCC OVERHEAD WATER TANK (450 Cum)** at Munalpath-3 in Biratnagar from eligible registered contractors having qualification as mentioned in the bidding document for the contracts as mentioned below under National Competitive Bidding.

4. The purchased bid document shall be sealed the original and copy of the bid in separate envelope as "ORIGINAL" and "COPY". The envelopes shall then be sealed in an outer envelope. All the envelopes shall be addressed to the Nepal Water Supply Corporation Head Office Tripureshwor. Envelop must bear the contract identification no, bidders name and address with contact Telephone/fax no. Alternatively, bidders may submit their Bids electronically through e-procurement section of DoR's web site <http://www.dor.gov.np> as specified in the instruction to bidder. Bids must be submitted on or before 12:00 Hours of 31<sup>th</sup> day (i.e.2071/04/28) from the publication of this notice (i.e. 2071/03/30).Documents received after this deadline shall not be accepted.
5. The bid and qualification documents shall be opened in the presence of bidders or their authorized representatives who choose to attend at 14:00 hours on the last date (i.e. 2071/04/28) at the Head office of NWSC, Tripureshwor, Kathmandu. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by bid security, which shall be **valid for 120 days** from the date of Bid opening.
6. If bidder wishes to submit bid security in the form of cash, the cash should be deposited in Current account no.0201017500742 at Nabil Bank, New Road, Kathmandu and should submit original receipt along with the bid.
7. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day.
8. Bidders are advised to visit site and the assess the actual site conditions accessibility, availability and cost of construction materials before submitting their bid.
9. A Pre-bid meeting will take place on the 20<sup>th</sup> day from first date of publication of this notice at Nepal Water Supply Corporation, Head Office, Tripureshwor at 13: 00 hours if that day falls on a Government holiday then the meeting will be held on next working day .
10. Bidders may bid as a single contractor or in a firm of Joint venture of maximum number of two (2) contract firms. In the case of joint venture, any one partner shall have to meet the required

criteria of specific work experience; the partner In-charge (lead partner) shall have minimum 40 percent of required average annual turnover and the liquid asset and other partners shall have minimum 25 percent of the same.

11. In case of discrepancies or error in bidding document, tender notice or any other documents the NWSC reserves the right to amend and correct at any time.
12. Subject uncovered under this notice shall be in accordance with Public Procurement Act 2063 and the Public Procurement Regulation 2064.
13. The unit price furnished in words shall prevail in case of any discrepancy between figures and words.
14. The employer reserves the right to accept or reject, wholly or partly any or all the bids or cancel the bidding process without assigning any reason, whatsoever.
